I, _____ have been informed of and understand that:

1. Emilah Dawn DeToro is not a health care practitioner licensed by the State of New Mexico.
2. Any treatment I elect to receive from Emilah Dawn DeToro is solely intended as a complement to (and is not in any way a replacement for) services provided by health care practitioners licensed by the State of New Mexico.
3. The desired outcome of any energy treatments or flower essence remedies received from Emilah Dawn DeToro is a greater sense of connection to myself and life as a whole.
4. Nearly all energy techniques, intuitive work and flower essence remedy mixing employed by Emilah Dawn DeToro are self-taught. Initial coach training and certification was received through Leadership that Works' Coaching for Transformation coaching certification program.
5. As with any energy work or flower essence remedy, it is possible for me to experience a temporary aggravation of symptoms (even ones from the past) after a session. If such an aggravation occurs, I should phone Emilah to discuss my experiences and discuss the possible need for another treatment or change in flower essence mix.
6. The rate for all sessions is \$125 per hour. The current gross receipts tax will be added for clients seen in person or who live in New Mexico and are seen by telephone or Skype.
7. Fees for all sessions are to be pre-paid via PayPal or check.
8. Fees for coaching packages are due on the first of the month prior to scheduled sessions.
 - a. Discovery Session - \$250
 - b. Removing the Obstacles Coaching Package (Two 1-hour session/month) - \$250
 - c. Fearless/Steady Transformation Coaching Package (three 1-hour sessions/month) - \$375
 - d. Transformation at Depth Coaching Package (four 1-hour sessions/month) - \$500
9. The full fee will be charged for any appointment I miss and fail to give at least 24 hours advanced notice of cancellation by telephone or email.
10. Fee for flower essence remedies is \$12 + shipping
11. I have a right to reasonable notice regarding any changes in fees (except those associated with changes in the gross receipts tax rate).
12. I have a right to complete and current information regarding Emilah Dawn DeToro's assessment (if she has made one) of my energy field and any flower essences she recommends.
13. I have a right to access (with reasonable notice and a mutually agreed upon time) my records.
14. My client records and transactions are confidential unless I authorize the release of such information or it is otherwise provided for by law.
